8. Address from Mungijong Police

- Snr Sargent Daryl Brandis provided an overview of the Mundijong Police Station and the areas of coverage (Byford to Karnup, Serpentine-Jarrahdale to Wandi), including general crimes the Police deal with.
- Working with the local government is important and the Police rely on the community to report issues.
- SS Brandis provided an overview of what crimes/issues local government can assist with and what the Police deal with.
- Invited everyone to go to the Police website and to report crimes via the webpage.
- Provided an overview of how incident reports are handled and allocated within the Station.
- Important to report issues when they are happening and to get the police to dispatch someone need to be present to get a results, in these situations it is best to use the Police phone number 131444.
- Nearest response for Wandi area is from Armadale.
- Neighbourhood is really important for crime prevention and reporting issues.
- Avoid opportunistic crime by being sensible and using common sense lock doors and windows of homes, keep valuables out of the car, put keys in an inaccessible place (i.e. not directly near the front door), lock cars, know your car rego number, identify your personal belonging so they can be tracked if stolen & found.

9. Address from Satterley Property Group – Shahan Hobson

- Shahan Hobson provided an overview of her role as Community Development Officer, creating the community you want to be in.
- Let Shahan know if you have an idea for community development activities.

- Have been working on some projects getting to know your neighbours, organising events, making opportunities for people to meet.
- Held the night stalk for the past 3 years.
- Working with the Wandi Progress Association and supporting various activities such as clean up days, bushland and wetland rehabilitation.
- Any suggestions come and talk to me after the meeting, or bring up suggestions through the newly elected committee. Opportunity for community sponsorship, local clubs and funding options.
